KNOW ALL MEN BY THESE PRESENTS, that the undersigned Homeowner in Waxahachie 147 Homeowners Association does hereby constitute, authorize, and appoint: **(please check one of the options below):**

Option #1 _____(name) (someone who will attend the meeting on your behalf)

By this designation of proxy, the Proxy Holder may attend and represent the Homeowner with the full power to vote and act for the Homeowner in the same manner, to the extent and with the same effect as if the Homeowner were personally present.
